Thank you for applying to Mojo's Hope to become a foster parent. It is with wonderful foster homes that Mojo's Hope is able to provide a second chance for so many loving and deserving animals with special needs. Please take your time when filling out this form so that we can match up the foster with the best temporary home. We want your experience to be one that is rewarding and enriching to you, your family and your foster.

Whereas, it is agreed: Mojo's Hope and this Foster Home are desirous of entering into a Foster Care Agreement to promote the humane and proper care of a rescued animal. Mojo's Hope has been established to provide the rescue and care of animals with special needs that may have been abandoned, neglected and/or abused by their previous owners. Mojo's Hope attempts to place rescue animals in temporary Foster Homes with people who will promote the aims of Mojo's Hope by providing a safe, secure, affectionate and healthy environment for these animals. Foster homes may be involved in the adoption process; however, Mojo's Hope arranges the meetings and has the final say in the placement itself.

To be considered for the volunteer position of Foster Parent, you must read and agree to sign the following:

I, _____ (your name), am over the age of eighteen (18) years of age.

- All animals in my household will be current on ALL their vaccinations before a foster animal is placed in my home.
- Any time that an ad is being run in the newspaper, on the news, or there is a potential placement for this animal, upon mutual agreement, arrangements will be made for a potential adopter to meet the foster animal. The Foster Home will not attempt to adopt out the animal and will forward all questions/concerns/adoption requests regarding the animal to Mojo's Hope.
- Foster Home is willing and able to provide loving attention and proper care for foster animals and understands that Mojo's Hope has the right to remove any animal from a foster home if that would be in the best interest of the animal and/or the Foster Home.
- Foster Home understands MH's mission is to help animals with special needs. The "Special Needs" designation covers many areas, including but not limited to behavioral, emotional, physical and medical. MH recognizes that when animals come into rescue, they may have special needs and each need is individualized. It is our goal to assist with their rehabilitation, so that those who are able to, can go to their furever homes to live out their lives happily and successfully. For those who have lifetime medical needs or are at the end of life stage, we will provide the necessary care to make their lives comfortable, filled with love and peace. If you are interested in our Pawspice/Palliative Care Fostering, please complete our addendum.
- If the foster animal doesn't work out; Foster Home agrees to give Mojo's Hope a minimum of 24 hour's notice to pick up the animal.
- In the event said foster gets loose, the Foster Home will contact a Mojo's Hope representative immediately, advertise in the local newspaper, put ads on Craigslist, use social media and make all reasonable attempts to locate said animal.
- The Foster Home will promptly notify Mojo's Hope of all changes in residence, mailing address and telephone number.

- Foster Home is willing to transport a foster animal to a veterinarian (Veterinarian: VCA Alaska Pet Care- Dr. Mandy Seymour- 3900 Lake Otis Pkwy- 907-562-7387) when necessary and will keep a record of the animal's name and medical care received to be given to Mojo's Hope.
- Foster Home will contact a Mojo's Hope representative prior to taking a foster animal to the veterinarian unless the situation is an emergency or cannot reach a Mojo's Hope representative within a 24-hour period.
- Foster Home is not responsible for the payment of vet care. Mojo's Hope takes full responsibility. Vet Care does not include pet food, toys, grooming or boarding fees.
- Should it become necessary to litigate in connection with any dispute concerning the care, treatment and/or custody of this animal, the Foster Home agrees to pay all court costs and reasonable attorney fees.
- Foster Home acknowledges that the Foster Home enters into this Agreement freely and with good will and, at any time, may choose to formally adopt this animal, following Mojo's Hope policies.
- Foster Home agrees to allow Mojo's Hope to take pictures that can be used for Petfinder, the local newspaper, social media, events, etc. that will assist in their adoption.
- Foster Home will agree to check-ins with a Mojo's Hope representative either by phone, email or text message. Check-ins will vary based upon the need of the animal.
- Foster Home agrees to send monthly full-bodied photos to Mojo's Hope, more if requested by MH.
- Foster Home will not make changes to Care Sheet provided unless approved by Mojo's Hope. This includes but is not limited to litter, food, bedding, schedules, any furniture provided for the foster animal.
- Foster Home or Mojo's Hope will weigh foster pet monthly. Weight will be sent to Mojo's Hope.
- I certify that all the information contained in this agreement is true and correct to the best of my knowledge. I authorize Mojo's Hope to contact any person or entity named in this agreement to verify the information given and I am willing to have a Mojo's Hope representative visit my home before this application is approved or during the time that I am fostering an animal for Mojo's Hope.

I understand that Mojo's Hope will not be liable for any injury or damage to persons or things caused by a foster animal in my care and I agree to indemnify and hold Mojo's Hope harmless from any such injury or damage.
